Bartles stated he is just trying to understand what is happening. He would like to see one person in charge. He doesn't feel the Seniors should be under the Supervisor's Office and doesn't remember it being a paid position.

Discussion followed regarding the Senior programming. Councilman Bartles feels Recreation should have precedent over the use of the Community Center also.

Discussion took place at this time regarding the Recreation Committee. Cooper feels three-year terms are better. Councilman Bartles asked about a residency requirement. Councilman Jones and Zick do not agree with a residency requirement and Zick feels School District requirement. Michael feels anyone interested. Councilman Chase asked Bartles the downside to no residency requirement and Bartles responded they are representing the Town.

Supervisor said she will write notes out for all for the Thursday Town Board meeting.

Motion by Jones second by Zick to go to executive session regarding personnel; return to regular order of business and adjourn. 5-0 passed.
