| Brief Description of Proposed Action (include purpose or need): The proposed action defines an Adult Use Retail Dispensary and permits it as a special permit use in the Hamlet Business (H-BUS) and Hamlet Main Street (H-MS) districts. Adult Use Retail Dispensaries are licensed by the New York State Office of Cannabis Management to sell cannabis and cannabis products to adults 21 years and older. No on-site consumption of cannabis products is permitted. The proposed zoning text would establish a minimum distance between dispensaries and schools, houses of worship, and other Adult Use Retail Dispensaries. It also regulates the permitted hours of operation, the view of cannabis plants and products from public sidewalks and streets, secure disposal, ventilation, and building security, among other issues.
